Checkpoint	Description	Direction
A	Barricade at Lornie PCN (men start point)	Start
B	Lornine PCN near bus stop #40261 (women start point)	Start / straight
C	First marshal at Lornie PCN	Straight
D	Second marshal at Lornie PCN	Turn right
E	Third marsal at Lornie Trail junction	Turn right
F	Fourth marsal at Lornie Trial near girl slope's junction	Turn right
G	Repeat Lornine PCN	Turn right
H	Turn right into Lornie Trail again	Turn right
J	Run pass Lornie Trail junction again	Turn right
K	Repeat girl slope again	Turn right
L	Exit girl slope and heading to end point	Turn left
M	End point near MacRitchie Reservoir carpark	Finish
